Overview

We are delighted to have the opportunity to serve your provider agency! We value your efforts in delivering quality care to your Illinois Department On Aging members and recognize the important role that you play in the homecare industry.

Now that you have completed the Provider Onboarding Form, we have outlined important next steps and dates specific to the option you have selected. Please review the details of your selected option and the EVV implementation timeline below. These steps provide guidance on all the different components required to ensure a successful implementation of EVV with HHAeXchange.

Providers working with HHAeXchange

Using the EVV system provided by Illinois Department on Aging

Illinois Department on Aging has partnered with HHAeXchange to provide an Electronic Visit Verification (EVV) solution at no cost for patient placement, scheduling, and authorization management for Personal Care Services.

For providers like you who have elected to use the free EVV solution in coordination with the Illinois Department on Aging program, HHAeXchange will work with your provider agency through a series of informational sessions and training webinars. These webinars are required to ensure your provider agency will be familiarized with the HHAeXchange platform, to meet the EVV mandate requirements. The informational sessions provide the background and major milestones required while the training webinars assist in understanding the different functionalities available in the HHAeXchange Provider Portal. As we move through these steps, communications will be sent to the user who completed the Provider Onboarding Form.

Ensure your provider portal is set up before go-live and work with your service providers to prepare them for EVV (i.e., download the mobile caregiver app and review the IVR phone instructions). Providers can also utilize the Support Center on their portal to search and review job aides and training material under the “Provider Portal Resource” page.</p>
5	TBD	<p>Linking Provider Portals to Illinois Contract Receive your Provider Portal credentials to login to the system and begin entering your caregivers. Ensure your portal is setup prior to go-live.</p>
6	Monday, July 29, 2024	<p>Go-Live for Illinois Department on Aging Providers are expected to start using the HHAExchange Provider Portal to schedule, and/or confirm EVV compliant visits.</p>
