










What is Electronic Visit Verification (EVV)?



The 21st Century Cures Act



10

Passed by Congress in December 2016, the 21st Century Cures Act requires that providers of Personal Care Services confirm visits via Electronic Visit Verification (EVV) by January 1, 2021.

The six data elements required to be collected to meet the Cures Act EVV requirement:

Register your agency for EVV by 7/12/24 and indicate how you will be performing EVV

- Your agency must have EVV in place by 9/3/24
 - Behavioral Health, MI Choice Waiver, MI Health Link, (Personal Care Services), and Medicaid Managed Care home health care services
- Your choices for performing EVV:
 - MI State Sponsored HHAeXchange EVV system at no cost
 - Third-party EVV system that integrates with HHAeXchange




