Minnesota Home Health and EVV



- Cures Act Mandate in effect as of January 1st, 2021
- Minnesota and Home Health is an hybrid model state
- Minnesota Home Health providers must implement EVV by October, 2023
- HHAeXchange has been selected as the State Aggregator and collect all visit data for each Home Health, regardless of the EVV system being used
 - Blue Cross
 - HealthPartners
 - Hennepin Health
 - Itasca Medical Care (IMCare)
 - Medica

 Option 2— Agencies currently using another 3rd Party EVV Solution: use your existing EVV system and import visit data into HHeXchange— HHA will route visit data to Minnesota.

Preparing Providers for MN-EVV Onboarding Continued




- Complete the attestation to begin onboarding process:
 - MN State Info Hub
 - Business Requirements Document MN
- Create a ticket with <u>3rd Party Integration Support</u> if no response is received within 48 business hours
 - Include the following:
 - Provider legal name
 - Provider Federal Tax ID
 - Should be 9 digits



Preparing Providers for Integration - Testing






- Prepare for EVV Integration Testing with HHAX by:
 - Review HHAX Testing Process document
 - HHAX will provide this document once access to HHAX environment is confirmed by provider
 - HHAX will provide test member demographic & authorization data to providers to utilize during end-toend testing
 - Message error codes begin on page 47 of the MN EVV Data Aggregator Specification
 - HHAeXchange EVV API Technical Specifications MN
 - Providers should contact HHAX Provider Integration team should you need assistance

Data Transmission Details



Transmission Frequency and Limits

For optimal system performance, HHAX recommends that visit data is sent in near real time. The expectation is that data is sent by the provider or EVV vendor to HHAX as it is added, changed, and/or deleted in the third party EVV system. Data that is unchanged should not be resent to HHAX. HHAX providers transaction statuses on a separate API call that is initiated by the third party EVV system. HHAX allows maximum five (5) calls per second per consumer.

Record Processing Workflow and Endpoints

There are two types of messages provided to HHAX by the third-party provider or EVV vendor; (1) caregiver demographic data and (2) visit information. Note that caregiver data is to be sent to HHAX first as a record is required to HHAX for visit data to load successfully. The provider and/or EVV vendor provides data to HHAX in JSON format only.

- Caregiver records are required to be sent individually to the API.
- Visit Data can be batched; up to 100 records can be sent per request.
